NOW IS THE TIME TO TAKE ACTION

An extensive number of legislative bills (including SB-50) have been introduced over the past two months in the State Senate and the State Assembly to address what too many are calling a housing crisis. While there is a housing shortage in some parts of our state, including the Bay Area, the crisis has been caused by excessive profit-driven development in the past (and potentially in the future as well). These bills would strip away local zoning control in support of high-density housing in places in our community, including Palo Alto and surrounding cities, where we never thought it would happen.

- SB 50 (overrides local planning)
- SB 330 (prohibits building moratoriums)
- AB 1487 (creates regional unelected taxing agency to collect \$1.5B/year)
- AB 69 and AB 587 (removes local control over Accessory Dwelling Units (ADUs)
- AB 725 (attack on single family homes)

The bills are in their respective policy committees **NOW** and will move out of committee by **April 26th**.

IDEAS TO USE IN CALLS AND LETTERS

- One-size-fits-all thinking doesn't work.
- SB 50 is a real estate acquisition bill, not a housing solution.
- Senator Wiener's YIMBY base calls single family homes "racist" and "immoral."
- Rather than solving the housing problem, the CASA bills, especially SB 50 and AB 1847 promote demotion, displacement, gentrification, and deepening income inequity.
- Cities don't build housing, developers do.
- CASA bills undermine local control without solving the problem of affordability.
- These bills fail to account for transportation, water, schools and other infrastructure needs.
- Top-down mandates are adversarial, when collaborative efforts are needed to get results.
